1. The above company is using Advantage LTL Inc for the purpose of obtaining discounts and receiving other benefits on freight shipments through Advantage LTL Inc., as well as their network of carriers.
2. Shipper agrees that all claims for goods shipped, goods damaged in transit, untimely shipments and all other claims shall be made against the carrier, and not against Advantage LTL Inc. Advantage LTL Inc., shall not be liable for any loss, damage or delay caused by the carrier's negligence, including the carrier's willful misconduct or reckless disregard for the condition, safety or timely delivery of the goods.
3. Shipper agrees to pay all attorneys' fees, costs, court costs and expenses incurred by Advantage LTL Inc., in connection with any efforts deemed reasonably necessary by Shipper for the enforcement of any of their terms of this agreement or the collection of the unpaid balance of any invoice or other sum due to Advantage LTL Inc.
4. Customer is responsible for payment of all shipments within 30 days of the ship date due to tariff regulations. Customer will provide correct description, quantity and classification of shipments. Advantage LTL Inc., will invoice for additional charges if shipment changes. If invoice payment is not received by Advantage LTL Inc., within (30) thirty days of the invoice date, the undersigned ("Shipper") shall pay full list price plus a finance charge of one and one-half percent (1 1/2%) monthly (annual percentage rate 18%) on all unpaid amounts, less credits and unpaid finance charges, from the date of the invoice. The finance charge shall in no event exceed the maximum rate, which is permitted by law. In the event any finance charge exceeds that which is permitted by law, any such excess shall be deemed a mistake and the excess shall, at the option of Advantage LTL Inc., either be refunded to the Shipper or credited to the unpaid balance of the account.

**CALIFORNIA. THIS AGREEMENT AND ALL OBLIGATIONS ARISING HEREUNDER SHALL BE DEEMED TO BE PERFORMABLE IN SAN BERMARDINO COUNTY, CALIFORNIA.** The parties agree consent to the exercise of jurisdiction by the courts of San Bernardino County, California to determine and dispute relating to this agreement performance hereunder, or any asserted breach hereof. No provision of this agreement shall be modified or limited except as agreed to in writing by the parties hereto. If any provision shall for any reason be or become invalid or unenforceable, the remainder shall not be affected thereby.
